7.1 Bylaw #668 - Land Use Bylaw amendment

8.1 North Peace Housing - Tax exemptions

CAO Gayton has consulted with the assessor regarding North Peace Housings request to be tax exempt on their properties, the assessor commented that Section 362 of the Municipal Government Act determines assessment exemptions.

RESOLUTION NO. 6-03-12-20

MOVED by Deputy Mayor Johnson that roll numbers #373000 and #412000, owned by North Peace Housing Foundation, remain taxable. And that roll # 340000 and # 414000 remain exempt. In the event that roll # 340000 and # 414000 property titles change before the end of a tax year, Village of Berwyn will be notified and taxes will be levied for part of the year.

Roll #273000 is a small strip of undeveloped land, and owned by Alberta Health Services it would also be exempt.

8.2 Peace Palliative Care Society

CAO Gayton discussed the information in the letter provided by the Peace Palliative Care Society: Asking for a donation; requesting assistance from our Community Services Director; Community Services Director reviewed the letter and is willing to help.

8.3 MSI and GTF Funding Allocation – 2020

In December 2019, the Government passed the Local Government Fiscal Framework Act. The Act includes a legislated commitment of \$2.5 billion in capital funding for the last three years placed of the Municipal Sustainable Initiative (MSI), which will then be replaced with the Local Government Fiscal Framework (LGFF). Municipal Sustainable Initiative (MSI) and Gas Tax Fund (GTF) is subject to the Alberta Legislature's approval of Budget 2020.
