## **BYLAW NO. 669**

## **UTILITY RATES**

A BYLAW OF THE VILLAGE OF BERWYN IN THE PROVINCE OF ALBERTA TO ESTABLISH RATES FOR WATER, SEWER, GARBAGE AND RECYCLING SERVICES.

WHEREAS, the Municipal Government Act permits a municipality to pass a bylaw fixing rates and charges for public utilities and services.

AND WHEREAS, the Council of the Village of Berwyn deems it appropriate that revenue from these rates and charges be sufficient to offset all costs incurred in operating utility and garbage services.

**NOW THEREFORE,** the Council of the Village of Berwyn, in the Province of Alberta, duly assembled enacts as follows:

Residential	\$14.00	\$15.00	\$18.00	\$3.25
Residential Reduced (on a Guaranteed Income Supplement, Widow or Disability pension)	\$8.00	\$ 9.00	\$14.00	\$3.25
Commercial	\$18.00	\$19.00		\$3.25
Institutional (school, lodge, villa)	\$22.00	\$67.00	\$21.00 (school only)	\$3.25
Unoccupied	\$14.00	\$ 11.00	\$17.00	\$3.25

THAT, the rate of \$2.00 per cubic meter be levied for all water usage.

THAT, the charges for a municipal utility service provided to a parcel of land are an amount owing to the municipally by the owner of the parcel.

**THAT,** If the municipality agrees to provide a municipal utility service to a parcel of land on the request of an occupant of the parcel who is not the owner, the charges for the municipal utility service provided to the parcel are an amount owing to the municipality by the occupant and not the owner.

**THAT,** any utility accounts in arrears for services supplied by the Village of Berwyn are subject to a 10% penalty.

THAT, if utility accounts are deemed uncollectable and the services have been supplied and billed to the property owner, the arrears may be added to the property taxes by way of Council resolution and may be collected in any of the ways provided for the collection of taxes as provided for in the Municipal Government Act, Revised Statutes of Alberta Chapter M-26 and amendments thereto.

THAT, Bylaw No. 654 is hereby repealed on 29th DAY FEBRUARY, 2020

THAT, this Bylaw shall come into effect March 1, 2020
