## VILLAGE OF BERWYN

## **BYLAW NO. 628**

A BYLAW OF THE VILLAGE OF BERWYN IN THE PROVINCE OF ALBERA TO LICENSE, REGULATE AND **GOVERN HAWKERS AND PEDDLERS.** 

WHEREAS pursuant to the Municipal Government Act, Chapter M-26 R.S.A. 2000, the Village of Berwyn Council has the power to pass a Bylaw within the Village

AND WHEREAS the Municipal Government Act, Chapter M-26 R.S.A. 2000, and amendments thereto, in Section 7 (e) the Village of Berwyn Council has the power to pass a Bylaw for municipal purposes respecting business, business activities and persons engaged in business;

NOW therefore the Council of the Village of Berwyn, duly assembled, hereby enacts as follows:

- 1. "Hawker" or "Peddler" means any person who, whether as a principal or agent,
  - a. goes from house to house selling or offering for sale any merchandise or service, or both, to any person, and who is not a wholesale or retail dealer in that merchandise or service, and not having a permanent place of business in the Village of Berwyn, or
  - b. offers or exposes for sale to any person by means of samples, patterns, cuts or blueprints, merchandise or service, or both, to be afterwards delivered in and shipped into the Village of Berwyn, or
  - c. sells merchandise or a service, or both, on streets or elsewhere than at a building that is his permanent place of dwelling or business in the Village of Berwyn.
- 2. That there shall be taken out by every Hawker and Peddler a license for which the persons obtaining same shall pay at the time of applying for such license a sum as defined by the following schedule:

a. Yearly Rate

Non-Residents \$250.00

b. Daily Rate

Non-Residents \$75.00

- 3. That every yearly license issued under this bylaw shall expire on the thirty-first (31st) day of December of the year in which it is issued.
- 4. That Hawkers and Peddlers shall only call upon residents between 9:00 a.m. and 9:00 p.m.
- 5. That every hawker or peddler licensed under this bylaw shall carry the license on their person at all times when conducting their business within the Village of Berwyn; and will produce the license for the inspection by a designated officer for the Village of Berwyn or upon the request of any customer that is approached within the Village of Berwyn.
- 6. A Designated Officer of the Village of Berwyn may at any time revoke or suspend a license issued under the provisions of this Bylaw for failure to comply with any of the conditions or regulations herein; and any person found guilty of a breach of this bylaw shall, upon summary conviction, be liable for a penalty of five hundred dollars (\$500.00).
- 7. That this bylaw repeals any and all previous bylaws for the regulation, licensing and control of Hawkers and Peddlers within the corporate limits of the Village of Berwyn, Alberta.
- 8. That this bylaw shall come into effect on the date of final passage thereof.
