# 6. **DELEGATIONS**

6.1 Scott Knuttila - Fire Department Update

Scott gave Council an update on the Fire Department.

To date forty-one calls have been attended; Berwyn Fire Department has only three active members at this time.

Fire Chief Scott Knuttila has been in charge of the Municipal District #135 Fire Hall since August 2021 as well as looking after Berwyn Fire Department; All three departments: Municipal District #135, Berwyn and Grimshaw Fire Departments need volunteers to join the Fire Departments; COVID seems to be a problem with getting volunteers.

Fire Chief Knuttila is working with FCSS/Community Services Director, Kristy Rees, they are working together to produce ideas for a recruitment push; Councillor Nettelfield suggested she could do a video

#### 7. NEW BUSINESS

#### 7.1 Rezoning Bylaw #681

A landowner has requested a rezoning of at 4911-50 Street. The proposed rezoning (fromC-2 to R-2) would permit more residential use. MMSA provided additional information.

Councillor Montie declared pecuniary interest and will abstain from voting as he is the landowner of the property in question.

Ken Montie spoke as a delegate, explaining the rezoning request.

Ken Montie's phone was put on mute as he was excluded from the councillors' discussion.

The motion was made by Council on the rezoning Bylaw #681 and was carried.

#### **RESOLUTION NO. 04-09-23-21**

During our MAP inspection, Municipal Affairs determined that our Public Notification bylaw, also referred to as the advertising bylaw, was defective and needed replaced. MMSA prepared a new bylaw for the Village of Berwyn and the existing Bylaw #655 will be rescinded.

The primary intent is to allow the Village to place advertising on our web page or Facebook page. This advertising will have legal standing.

CAO has recommended that Council pass the first reading, then the new bylaw will be advertised as noted in Section 606 of the Municipal Government Act.

#### 10. CHIEF ADMINISTRATIVE OFFICER REPORT

10.1 CAO Report

E-Construction has requested with Council's permission to delay the paving project until next spring.

Due to COVID-19, they are experiencing difficulty in getting sufficient staff to complete projects this fall. Update: an email received on September 21, 2021 advising CAO Gayton that they will be proceeding with the 2021 road work, they expected to begin on September 22, 2021.

In the past the Village of Berwyn has had a 911 and fire dispatch contract with the City of Grande Prairie, and the MD of Peace had a separate contract. We are looking at amalgamating those two contracts into one contract. The Village and MD would then negotiate on how to cost share the one contract.

GWST Water check out the lagoon, and provided advice on our problem with the anaerobic cells. Taylor Rudrum will come out to the October 14<sup>th</sup> meeting, and he will speak on the matter further.

Staff commenced draining the large cells at the lagoon on September 13<sup>th</sup>, Alberta Environment and the MD of Peace were notified of the draining at the lagoon.

Mayor Hockley informed Council that CAO Gayton passed on to her that he had talked with John McLeod regarding the ice allocation meeting he attended on September 9, 2021 in Grimshaw, no interest from other clubs was shown regarding ice rentals in Berwyn.

The contractor finished pouring sidewalks, but they will be returning to do grinding on tripping problems. **RESOLUTION NO. 08-09-23-21**
